## **Parish Council Meetings**

During the year the Parish Council has returned to meeting in person at the Village Hall and has continued to meet on the first Tuesday of every month. We have considered a range of local planning issues and our comments have been forwarded to ERYC. 31 planning applications have been considered and we have also debated the Hornsea 4 and Dogger Bank Wind Farm projects, considered proposals for two solar farms and the Compulsory Purchase Orders associated with A164 improvement project and assessed the impact of proposals to extend the oil well project at Wold Newton on HGV traffic through Skidby village.

A number of residents have attended our meetings to raise specific concerns, and we have received representations in relation to planning, the unauthorised felling of trees, flooding in Orchard Road, access to land, overgrown hedges, speeding, inconsiderate parking near the school and village hall, unpleasant odours and play equipment. The Parish Council has welcomed this resident involvement and has done its best to address the concerns raised, liaising with other agencies where necessary. Residents have also expressed interest in undertaking planting around the village, and although the establishment of a Skidby in Bloom group proved unsuccessful, it is hoped we can work with the residents on proposals for more planting in the coming year.

The Parish Council liaises with several departments within ERYC on issues including maintenance of roads, footpaths and verges, flooding, speeding vehicles and parking. We continue to pursue pupil safety issues and recently met with the Head of Cottingham High School to discuss options to improve the safety of pupils using the Keldgate crossing. During the year ERYC has introduced a Town and Parish Council Charter with the aim of improving communication and co-operation with local councils. Skidby Parish Council has adopted the Charter and the Chairman and Vice Chairman recently attended the first Town and Parish Council Network meeting with Councillors and officers from ERYC. The Parish Council has also adopted a new Code of Conduct following the model agreed by ERYC.

Members of the Council have welcomed ERYC Ward Councillors Gill, Meredith and Smith who have continued to offer their support and have provided valuable updates. The Ward Councillors also liaise with ERYC on our behalf and in particular this year we have worked with the ward councillors on parking issues on David's Close, proposals for a footpath along Eppleworth Road, and issues of traffic and speeding in the village. We have also submitted a proposal that ERYC's scrutiny committees consider the limited sanctions available to deter landowners from removing large numbers of trees without the necessary permits from the Forestry Commission. This has been included as part of a wider consideration of tree planting, nature partnerships and biodiversity.

The Parish Council has also been pleased that PCSO Dale from Humberside Police has attended our meetings this year to report on crime, anti-social behaviour or traffic offences and has been able to reassure the Council about the generally low levels of crime in the parish. We have submitted a number of suggestions for Community Payback projects and have arranged for dog fouling signage to be updated throughout the village.

## **Parish Priorities**

The Parish Council agreed a number of priorities for 2021 - 2022, including improvements to the cemeteries, development of proposals for replacing the play equipment at the Playing Fields , commissioning and installation of a new Statue Trail progressing the Neighbourhood Plan and the Skidby in Bloom Group.

### Cemeteries

A number of improvements have been made in the Cemeteries during the year including tree work, new paths at Little Weighton Road cemetery and a spruce up of the Garden of Rest. Cemetery Regulations have also been reviewed and updated.

## **Playing Fields**

We have continued to work on obtaining a range of designs for new play equipment at the Playing Fields and investigating funding options. We have started to consult with local schoolchildren on what they would like to see and how they can be involved. We were very impressed with the maturity and enthusiasm of the pupils we met with and the fact that they have already started fundraising. Progressing this project will be our top priority for 2022 – 2023.

Repairs were completed to the Pavilion following the water leak and tiles were replaced following wind damage in the autumn. The pitches are being increasingly well used and we currently host both cricket and football teams as well as goalkeeper training.

## **Jubilee Statue Trail**

During the year the Parish Council has progressed the manufacture and installation of 5 CorTen steel statues representing different aspects of Skidby life. I would like to thank ERYC for agreeing to locate two of the statues on their land which has enabled us to create a statue trail around the village. The trail is to be launched as the Jubilee Statue Trail as part of our activities to celebrate the Queen's Platinum Jubilee in June 2022. Particular thanks go to Councillor Paul Browning and Neil Cameron for their hard work in seeing this project through to fruition.

## **Neighbourhood Plan**

The next stage of the Neighbourhood Planning process will involve consultation on the draft policy priorities. This has not been progressed this year due but it is hoped this work will recommence in 2022 – 2023.

## **Skidby in Bloom**

Despite initial interest in establishing a Skidby in Bloom Group, residents were reluctant for it to be a formally constituted group and preferred to operate informally in consultation with the Parish Council. It is hoped that residents will help with proposed planting around the statues for the Jubilee and will continue to suggest area that could be improved.

## **Events**

In November, Councillors T. Hasnip, K Haslam and L. Varey and the Clerk J. Price attended the Remembrance Service held at the War Memorial at St. Michael's Church in the presence of the Deputy Lord Lieutenant. I laid a wreath provided by The Orange Grove Florists.

We held our annual Christmas lights switch on event at the end of November to coincide with the Christmas Fair at the Village Hall. We were very grateful to Mrs Markham and pupils from Skidby Primary School as well as the Hull Musical Theatre Company who braved the cold to sing carols around the tree.

The VE75 display has been completed and installed in the noticeboard on School Green to complement the commemorative bench installed last year. Thanks to Richard Grice for providing photographs and information and to Natty Browning for putting the display together.

As part of the Jubilee celebrations two trees have been planted on Church Green to replace those lost earlier in the year. A further tree will be planted on School Green later in the year. These will form part of the Green Canopy and will have plaques commemorating the Platinum Jubilee.
